## Gloucestershire County Council Cycling Scheme – 30<sup>th</sup> October–3<sup>rd</sup> November 2017

Please find attached a letter about the Bikeability Cycle Training Scheme ran by the Road Safety Team at Gloucestershire County Council. If your child would like to take part in the training please return the 2 reply slips to school by Wednesday 18<sup>th</sup> October. Please ensure your child's cycle is in good condition, there are guidelines on the back of the letter. The instructor will not allow your child to take part if the cycle fails the checks.

If you would like your child to take part please complete the form below and return it to school. The cost of the course will be  $\pounds 8.50$  per child paid via Parentpay. The cost is heavily subsidised by County. If your child is eligible for free school meals then the training is free.

However, before agreeing to your child being considered for the scheme, I must advise you that parents will be responsible for transporting their child's bicycle to and from school.

The storage of bicycles during the training period, will be in the school grounds during the day and inside the school building at night, but it must be understood that the school cannot be held responsible for the safety of the bicycle and you should make your own insurance arrangements. All bicycles must be taken from the school promptly after the last session.
